

VOTE DESCRIPTIONS

1. H. 4018 – ID Theft (5/9/07)

S. 4144 – ID Theft (7/17/07)

The passage of the Identity Theft Prevention Law set new standards for how personal information is protected and disposed of, ensuring that entities collecting consumer data must notify affected individuals if their personal information is lost or stolen. It also allows consumers to safeguard their own information by “freezing” their credit reports.

2. H. 4637 – Transportation Bond Engrossment (4/2/08)

The state Legislature passed transportation bond legislation that authorizes \$700 million for public transportation improvements and expansions, such as the Green Line extension to Somerville and Medford, additional stops on the Fairmont commuter rail line, more parking at transit hubs, and a study on linking the MBTA Blue and Red lines.

3. S. 4637 – Transportation Bond (4/3/08)

H. 4637 – Transportation Bond Concurrence (4/8/08)

The passage of the Transportation Bond legislation authorizes \$700 million to public transportation improvements and expansions such as the Green Line extension to Somerville and Medford, additional stops on the Fairmont Commuter rail line, more parking at transit hubs, and a study to link the MBTA Blue and Red lines. The Senate version contained a reform component that allows for civilian flaggers to replace paid police details at certain transportation projects. The amendment prevailed and was included in the House concurrence vote.

4. H. 4645 – Tax Loopholes (4/10/08)

S. 2685 – Tax Loopholes (5/6/08)

The passage of the Tax Fairness Bill closed an estimated \$400 million in corporate tax loopholes, restoring integrity to our tax code and leveling the playing field among all taxpayers.

5. H. 4346 – Trans Fats (6/4/08)

An Act Protecting the Public Health restricts the presence of trans fats in foods served in restaurants and hotels to help protect the health of Massachusetts citizens. This bill did not pass.

6. H. 678 – National Popular Vote (7/9/08)

The National Popular Vote Bill establishes an interstate compact—or agreement—among joining states so that their electors would vote for whichever candidate wins the national popular vote, meaning that for the first time every vote counts. This bill did not pass.

7. S. 2660 – Rx Drug Marketing Reform (4/17/08)

H. 2660 – Rx Drug Marketing Reform (7/16/08)

The passage of the Health Care Cost Control Law will lower health care costs and promote patient safety by: limiting gifts that drug and medical device companies can give to doctors; establishing an evidence-based prescribing program; establishing uniform billing codes; disclosing hospital infections and more.

8. S. 2807 – Election Day Registration (7/29/08)

The Election Day Registration Bill allows voters to register to vote on Election Day, thereby increasing voter participation, ensuring that votes are counted, and extending the fundamental right to vote to new constituencies. This bill did not pass.
