

### 2009-2010 Legislative Scorecard

Our scorecard follows seven key public interest votes considered in the Massachusetts Legislature during the 2009-2010 legislative session. The Senate recorded votes on seven of these bills, the House of Representatives voted on six.

#### **VOTE DESCRIPTIONS**

#### S. 2022- Auto Insurance Appeals Board, No. 21, (3/25/09) H. 2022- Auto Insurance Appeals Board, No. 48, (4/2/09)

The passage of the bill preserved the auto insurance appeals board. The appeals board allows drivers to appeal the "at-fault" determinations that can often result in significant increases in auto insurance premiums. The bill passed after the state's insurance commissioner announced plans to eliminate the board.

### 2. S. 2087- Transportation Reform, No. 83 (6/18/09) House voted on S. 2087- Transportation Reform, No. 151 (6/18/09)

The passage of this bill mandated an overhaul of the Commonwealth's transportation agency, consolidating all of the former transportation authorities into a single, integrated agency. MassDOT encompasses the former Executive Office of Transportation and Public Works and its divisions within the Massachusetts Turnpike Authority, the Massachusetts Highway Department, the Registry of Motor Vehicles, the Massachusetts Aeronautics Commission, and the Tobin Bridge Authority. MassDOT will also provide oversight for the Massachusetts Bay Transit Authority (MBTA) and the Commonwealth's 15 Regional Transit Authorities.

In addition to consolidation measures, the reform law ended the practice of allowing new MBTA employees to retire after 23 years, and shifted employees and retirees to the state health insurance program.

### 3. S. 2324- Economic Development, Transparency and Fiscal Accountability, Amend# 69, No. 213, (4/8/10)

If passed, this amendment would have allowed the public to see details about all of the state's economic development investments by requiring the DOR to report on tax reductions, tax credits and subsidies, direct grants and more. All investments would have included economic development benchmarks by which the investments could have been measured and compared. If any investment did not meet these benchmarks, the recipient would have been required to return it.

## 4. H.4600- State Budget Transparency Website, Amend# 735, No. 376 (4/28/10) S.4, State Budget Transparency Website, Amend#142, No. 260 (5/26/10)

The new rules create a state budget website, which will make much of state spending and revenue sources, for all state agencies including quasi publics, available for public scrutiny. The website will allow the public, including local officials, businesses, lawmakers, citizens, and others, to see where the state is spending money.

### H.4600- Tax Credit Transparency, Amend#734, No. 377 (4/28/10) Jay Credit Transparency, Amend#58, No. 254 (5/26/10)

This reform will provide greater transparency of certain tax credits granted to businesses in the Commonwealth. The law requires enhanced reporting and disclosure about which businesses are receiving certain tax subsidies and how much those businesses are receiving. The information will be available on the state budget and spending website.

#### S. 4, Weaken or eliminate Rx drug gift ban law, Amend#291, No. 270 (5/27/10) House voted on S.2380, Amend#13, No. 427 (7/7/10)

In 2008, as part of the effort to lower the cost of prescription drugs, the Legislature passed the Rx Drug Gift Ban, prohibiting drug and medical device companies from giving gifts to physicians and others who prescribe medicine. The law also promotes transparency by requiring the disclosure of any allowed payments from industry to prescribers.

The Senate voted down an amendment that would have eliminated restaurant meals from the list of prohibited gifts.

The House passed an amendment to repeal the whole law. The repeal language did not pass the conference committee and was therefore not included in the final bill when it passed.

#### 7. H.4156- National Popular Vote (7/20/10), No. 442 S.4156- National Popular Vote (7/15/10), No. 341

The passage of this bill puts Massachusetts in an interstate compact that commits each participating state's electors to voting for the presidential candidate who wins the national popular vote. The compact takes effect when the total of participating states' electors constitutes a majority in the Electoral College.
