

Our scorecard rates legislators from the 2011-2012 session on a selection of MASSPIRG priority issues: the price of health care, consumer protection, recycling, transportation and democracy.

Members of the House are scored out of seven points, and members of the Senate out of six. Since the Legislature only votes on a fraction of the bills filed, and even then their votes aren't always recorded, we used three criteria: roll call votes when available (legislator's position identified), voice votes where bills pass or fail with no record of how an individual legislator voted (therefore every legislator's score rises or falls with the final vote), and a public letter and survey listing lawmakers' positions.

VOTE DESCRIPTIONS

VOTE 1: Price Stickers Repeal

This bill, H4089, allowed supermarkets and other retailers to eliminate price stickers if they install aisle scanners, reducing information available to consumers. The bill passed. MASSPIRG urged a NO vote. H. Voice vote, (5/17/12); S. Voice vote, (6/25/12).

VOTE 2: Transportation Funding

This bill, H4174, provided \$51 million to mitigate service cuts and fare hikes on the MBTA. The bill passed into law. H. Roll Call #294, (6/27/12); S. Roll Call #235, (6/27/12).

VOTES 3 and 4: Updated Bottle Bill

This bill, H890/S1650, added bottled water, sports drinks and other beverages to the current bottle deposit system, promoting recycling instead of litter or trash. The bill passed the Senate but was not voted on in the House.

Column #3, H. and S. Public Score Card—released June 26, 2012, prompting members to declare their position. Column #4: S. Voice vote, Amendment to S2350, (7/19/12); H. Public Letter to Speaker DeLeo urging a vote on the Bottle Bill (7/30/12).

VOTE 5: Citizen's United Resolution

This resolution urged Congress to pass and send to the states for ratification a constitutional amendment to restore the First Amendment and fair elections to the people. The resolution was adopted. H. Voice Vote, (7/31/12); S. Roll Call #273, (7/26/12).

VOTE 6: Health Care Cost Containment

This bill, S2400, included new health care reforms estimated to save \$200 billion in projected health care expenses over the next 15 years. The reforms promote investment in public health and administrative efficiency and encourage insurers and health care providers to adopt alternative payment and care delivery models focused on patient health rather than the quantity of services and tests performed. This bill passed. H. Roll Call #357, (7/31/12); S. Roll Call #295, (7/31/12).

VOTE 7: Repeal of Prescription Drug Gift Ban

This amendment (#230 to H3400) repealed the prohibition of gifts from drug companies to physicians adopted in 2008 to lower the cost of health care. The amendment passed. MASSPIRG urged a NO vote. H. Roll Call #43, (4/26/2011).
